Supervisor's Comments

Supervisor Wicks stated that he watched the inauguration. He said that Amanda Gorman's speech was poised and worthwhile for everyone to watch. He wished the new President great success and hopes that everyone else does as well.

Town Board Comments

Councilor Moore said the work sessions are very productive and thanked everyone for coming. The other Board members concurred and thanked everyone for watching.

Councilor Kudarauskas said the 8 x 8 phone system will be live in about two weeks. When people call in, it will be more user friendly. Voicemail will be transcribed over to email as well.

Department Head Reports

Mr. Yager gave an update on Motion B. He said the increase from 30% to 50% is the maximum lot coverage on industrial parcels. The Radisson lot coverage has a max of 50% and the town has limited industrial land [available]. Mr. Yager says TOL should try to use, or be as flexible as possible, to encourage industrial development in the town. 30% is restrictive for industrial development. There is a site on the Northeast corner of Hencle Blvd., a parcel that is [for a] one-million-seven- hundred square foot rental facility [a large warehouse facility] that will cover 92% of the parcel. Mr. Yager says TOL doesn't want to lose an opportunity to attract a large business from an economic growth standpoint because of an overly restrictive lot coverage percentage. He said that until a formal application has been presented, he can't say what is going in there.

Supervisor Wicks said it is a good idea to have this kind of facility there, as it is an easy "in and out" to the area. He said it is not in a residential area. It's a perfect location for that type of business. The project would extend the sewer line and there is a water main in the area as well.
