#### **Citizens Comments**

**Norma Newman of the Lysander Cemetery** stated that she is grateful that the cemeteries are in the budget again this year, as it helps the caretakers care for the remaining cemeteries, so that the town will not have to take them over. She advised that last year, Lysander Cemetery used additional funds for mowing, and they have been able to install two roads for easier access.

Robert Markham of Lysander/Plainville Cemetery thanked the Board for the funds for the cemeteries.

**Ruth Troy of Canton Woods** thanked the Board for their continued support of the Senior Center. She specifically thanked Councilor Geraci for his public recognition of the good work the center provides.

Ed Schmitt of Hayes Road asked for an update regarding the NO PARKING signs on Hayes Road.

**Fred Burtch** of Plainville Road thanked those who came out to speak regarding cemetery funding. He thanked members of the Lysander Cemetery and mentioned that he has been digging graves there for 17 years, and receives phone calls regarding burials occasionally. He uses his own equipment, and tends to the cemetery as needed.

Mr. Burtch mentioned the speeding issue on his road, and said that 250 tickets have been issued in the past two months in the course of the time the police have been sitting there. Additionally, he spoke with the Highway Superintendent about getting millings to place in the area where the Troopers park so it will be safer, as it is well hidden. He asked the Board for \$10K for public safety in the Lamson/Plainville Church corridor.

**Sherri Woods** of the Plainville Rural Cemetery Association thanked the Board for the extra money allowed for use of expenses. So far there have been \$7,200 in mowing costs this year. She said the cemetery doesn't make money unless someone is buried there, or buys plots. She noted that the costs have risen 30% from last year, and the cemetery is also faced with an increase in liability insurance.

**Charlie LaPrease**, President of Canton Woods/Board of Directors, thanked the Board for its continued support and noted the importance of the center; and now with the potential company coming, the funding will help to accommodate more people.

#### **Town Board Comments**

**Councilor Geraci** spoke about Canton Woods and thanked them for coming to speak on its behalf. He gave the background of the Center, as the Town of Van Buren, along with the Village of Baldwinsville agreed to create a senior center, where each municipality contributes \$66,950. He noted that the total amount costs residents approximately \$8. He said that Canton Woods is a jewel in our community.

**Councilor Kudarauskas** stated that he appreciates the services Canton Woods provides, and is glad to hear that Van Buren is contributing as well.

**Councilor Rode** stated that he appreciates the comments regarding the cemeteries, as he has family in those cemeteries. He asked the audience to make sure and vote, and reminded the public that the public hearing on the budget will be held on November 3.

# **Department Head Reports**

**Kevin Merrill, Parks and Recreation Director** spoke about the upcoming Halloween window painting event. He noted that registration is live on Facebook and the Town of Lysander website. He reminded residents that on October 22nd the Chamber is presenting 'Trick or Treating' in the Village of Baldwinsville from 10:00 AM to 1:00 PM, all will conclude with a Haunted House at Lysander Park sponsored by Orange and Olive.

**Mr. Merrill** said that the Spence Field lot is 100% usable. There are about 66 additional spaces; in the future will be approximately 70 additional spaces. There are boulders around the lot and field.

**HW Superintendent Ken Svitak** stated that he hasn't had time to speak with Mr. Voss regarding signs for Hayes Road. It is on his list. HW is working on mailboxes on Exeter. They finished the road and mailboxes have been moved back into place.
