Mr. Rode referred to the posting the preliminary budget issues during the work session for the budget as there could not be a dialogue or question and answer session.

### Fred Burtch:

Mr. Burtch said he would help remove some of the trees from the Lysander cemetery with the excavator and clear the road out.

Jacksonville has more burials than Plainville or Lysander.

New Open Meetings Law regarding documents being discussed at a Town Board meetings made public on the website and on the signboard. **Supervisor Wicks** said they will comply with the law.

#### Will Stowell spoke about:

Regarding cannabis legislation said it was premature to decide what to do as a Town based on the legislation.

#### **Supervisor Comments**

**Supervisor Wicks** said we want to help our cemeteries. As the Town Clerk and Town Attorney mentioned we would have to take them over. He said there is a consensus that we will do what it takes to keep the cemeteries running.

#### **Town Board Comments**

Town Board members chose to move on to the agenda. **Councilor Diamond** likes cemeteries and pontificated about how he enjoys history. **Councilor Geraci** spoke about the wreath sale by Canton Woods and all proceeds go to Canton Woods Senior Center. The sale notice will be on the website.

#### **Department Head Reports**

**Kevin Merrill, Parks and Recreation Director** mentioned the Holiday window painting this Saturday in the Village from 10:00 to 1:00 – there are 200 kids signed up. Asbestos at the house in the park abatement almost completed. The sidewalk is being worked on and the concrete should be poured on Tuesday.

**Dina Falcone, Town Clerk** spoke about the Canton Woods wreath sale. She will also take orders from people who would like to purchase them and the wreaths can be delivered to Town Hall.

**Mr. Yager** discussed the LED conversion project. He said November 15th is closing date on the LED conversion. They will start the conversion on November 16th. **Supervisor Wicks** said he has received a number of calls and gave those tentative times as to when lights are going in. They were anticipated start dates. National Grid and the PSC were holding off on a closing date. The project should take a month to complete.

#### Assessor's Report

Senior citizen and disability exemption renewals for 2022 have been mailed to property owners. They are processed and updated as received. The deadline for exemption applications or renewals is March 1<sup>st,</sup> 2022. All other exemption renewals - agricultural, nonprofit, etc. are being processed for mailing in December.

Inventory changes for 2022 are entered as building permits are completed. Field review of building permits will be scheduled October thru February. As weather permits.

A total of 373 Town of Lysander sales were reviewed for 2022 valuation purposes. These valuation useable sales will be used by the State to determine the full market values for the 2022 assessment roll.

A review of all residential neighborhoods sales/assessments will be completed using a+10% time adjustment. This review will indicate the level of assessment in each neighborhood and actions needed to maintain 100% level of assessment for 2022.

Commercial properties will be reviewed sales/assessments by property use type. County wide commercial sales will be used.

Vacant land will be reappraised if review of sales/assessments indicate a level of assessment below 95% for 2022.

The State Office of Real Property Tax Services has been notified that the Town of Lysander will be maintaining assessments at 100% for 2022. The deadline for notification is November 1<sup>st</sup>. Preliminary numbers from the State indicate a residential value increase of 6% to 12% for Onondaga County. Sales used July 1, 2020 thru June 30, 2021.
