Comments Regarding Public Hearing

Comments Regarding Public Hearing

Supervisor Wicks: *Is there anyone that is wishing to speak regarding the proposed amendment to the Solar Code?*

Ms. Falcone: We have an email from Carson Weinand. Would you like me to read it? Should I stand up?

Supervisor Wicks: You can, sure.

Ms. Falcone: This is from Carson Weinand, he is the developer from CVE North America.

"CVE would like to submit the following statement for the public hearing tonight:

CVE intends to develop and construct a 6MW community solar farm on a 77 acre portion of parcel 079.-01-10.1, having an address at 2825 West Entry Rd within what is known as the

"Radisson Corporate Park." The parcel is zoned PUD Industrial and solar would be a permitted use under the current industrial zoning code. CVE has worked extensively, for over 8 months, with the Empire State Development Corporation to agree on a deal and execute an Access Agreement, signed by Holly Leicht, EVP, Real Estate Development and Planning for ESD on 10/29/20.

The project would have a useful life of 35 years and allow over 300 local residences to subscribe and receive monthly discounts on their utility bills. Construction would take about 4 months and require 50 local laborers. Ongoing maintenance would require monthly visits from a local electrician and landscaper. A PILOT would be executed with the appropriate authorities having jurisdiction and generate an estimated \$25,000 - \$40,000 / year, without any additional strain on town services – including schools, traffic, sewer, water, and police.

When CVE started negotiations with ESD, CVE consulted with the Town to ensure land use and zoning was favorable. It's unfortunate to see the possibility of a last minute change. CVE is eagerly trying to execute under Governor Cuomo's Renewable Energy Standard, which call for 70% renewables by 2030, yet it's discouraging when localities prevent that from happening.

Furthermore, the site itself is largely covered in wetlands and will not be able to host the type of facility that the Town hopes for. There is about 15 - 20 acres in the south east corner that provide just enough space to make solar economical. This site, as a whole, will never be able to support the construction of another facility like the McLane or Paperworks or Anheuser Bush facilities nearby.

Thank you for your consideration. Hopefully, the Town understands where CVE is coming from – and the impacts such zoning change would have on the solar development community."
