Mr. Yager:

Bob, do you want me to just do a little presentation that we're talking about? So we have these – there are three previously approved zone changes that were done. One was in June of 2018. One was done in August of 2018. And another one was done in August 2018. And they are this parcel here which is the height of the medical building on Route 31. They wanted to do additional parking there and they couldn't do it without this change. This parcel here - which is adjacent to the new self-storage facility at the corner of 48, Church and Hencle Boulevard. This one here which was always an old restaurant but it was never zoned correctly, so we just changed it to a commercial zoning. And then this parcel here, which was always part of the Radisson PUD - the use in the Radisson PUD general project plan changed in 2016, which was about the exact same time we updated the last map and this parcel ended up being changed to AR 41. It still should have remained in the Radisson PUD. So we're correcting that mistake. So those are the changes that are included. This map is compared to the old map.

Citizens Comments

Cindy Clarke of West Genesee Street thanked the Board members who voted "yes" on the moratorium regarding assessments. She also told the Board members that she appreciated how they discuss how TOLs money is spent by postponing projects until costs come down.

Fred Burtch of Plainville Road spoke about a safety issue (the dangerous intersection) on Plainville Road and Church Road. He referred to a petition that was signed by all of his neighbors in 2010. "...citizens residing in the immediate vicinity of the intersection of Church Road and Plainville Road in the Town of Lysander, hereby petition and request that the Town Board of the Town of Lysander extend the 30mph speed limit and add a 30-mph speed limit sign half mile south of said intersection on Plainville Road." Additionally Mr. Burtch demonstrated the safety issue on a white-board where it was explained to the Board how dangerous the intersection is. Mr. Burtch requested he be a part of that meeting/conversation, as he has firsthand knowledge of the traffic problem and that he and the town can work together to mitigate the safety issues in that area.

Supervisor Wicks acknowledged the issue and said that it is an enforcement issue, and he would contact who he knows to discuss the issue. He also suggested a speed study, however, the speed on those roads has already been reduced.

Town Board Comments

Councilor Rode expressed his concern as to what a speed study would accomplish regarding the Plainville Road traffic safety issue, as it is more of an enforcement issue than a speed issue at this point.

Supervisor's Comments

Supervisor Wicks spoke about the water chestnut problem along the river bordering Lysander and Van Buren. The DEC will not allow pesticides in the water. Senator Mannion was in the Plainville area and was made aware of the water chestnut issue in the Jack's Reef area. There are grants for the removal of water chestnuts. **Supervisor Wicks** sent a letter to the County Executive and County Legislator Brian May regarding same. TOL is working with the state to get funding to allow water chestnut harvesters. It will be an intermunicipal effort.

Department Head Reports

Kevin Merrill, Parks and Recreation Director stated that boulders will be placed along the area where the near-accident occurred at Spence Field. He thanked BYSA and welcomed Mackenzie, the Treasurer of BYSA. BYSA provided a check to help with the safety of Spence field. He noted that the following programs are available, and each of them have details regarding registration on the website: Pickleball, Arts and Crafts Club, Video Gaming Club, Yoga in the Park, Chess Club, and Stargazing\Campout.

Mr. Merrill reported that the Life Worth Living 5K brought 209 runners and 93 walkers, and their fundraising goals were met.
